Rules and Regulations

Eligibility

1. Be between the age of 4 and 8 by June 1st, 2019 (unless otherwise pre-approved)
2. Have executed all consents, waivers and /or agreements presented for the competition
3. Abide by all rules and regulations of the Miss Rodeo Oregon Sweet♥Heart Pageant
4. Have not been disqualified or had a title forfeited from any pageant

Entry Requirements

1. Submit a complete and notarized application.
2. Pay a \$95 entry fee
3. Submit 1 5x7 vertical head and shoulder color photo in western attire (please also include an electronic version with application)
4. Send proof of age (i.e. copy of birth certificate)
5. Return a notarized Release of Liability
6. The above requirements must be post marked by the deadline date.
7. Each pageant contestant will have their biography and photo will appear in the pageant program, free of charge. Each contestant is asked to sell at least one ¼ page ads for the Junior/Teen Miss Rodeo Oregon pageant program. Contestant and her family are welcome to purchase additional ads. These can be well wishing for contestants or advertisements from businesses and/or individuals. Several sponsors may go in together to pay for one ad.
8. Each contestant is encouraged to bring to the pageant registration a silent auction item of their choice. The funds generated through this auction will go to benefit the Junior/Teen Pageant Program and Miss Rodeo Oregon Sweet♥Heart winners.

Suggested Attire:

- Saturday Parade – Western jean outfit (Parade colors for our entry are Red White and Blue)
- Saturday Luncheon – Western jean outfit (dresses or skirt outfits are ok but not necessary)
- Saturday Rodeo Performance – Western jean outfit

Other Pageant Requirements:

- All contestants will room with a parent or guardian.
- A parent or guardian is responsible for transporting their daughter to all pageant functions.
- Sweet♥Heart contestants will follow the same schedule as the other two divisions but will be under the supervision of their parents or guardian when not competing.
- During competition, all contestants will be seated together and will be supervised by some of the pageant committee;
- Parents are urged to attend all “open” functions.

Contestant Expenses:

- Contestants in the Miss Rodeo Oregon Sweet♥Heart pageant are required to pay their own transportation to and from the pageant, lodging, food, entry fees, ads in pageant program unless sponsored, and any other expenses that might occur during the pageant.

Pageant Authority and Sponsors:

- The pageant is an annual event, which will be held in conjunction with the Junior/Teen Miss Rodeo Oregon pageant. The Miss Rodeo Oregon Association conducts the actual competition and arranges the judges, awards and entries.
- The Miss Rodeo Oregon Association has complete authority over the pageant competition and any activities of the contestants during the competition.
- All problems or complaints are to be referred immediately to the Junior/Teen Miss Rodeo Oregon Pageant Director.

Contestant application form, waivers, picture, program ads/money and all other required information must be postmarked by **June 1st, 2019** mailed, emailed or hand delivered to the Junior/Teen Miss Rodeo Oregon Pageant Director. Upon receipt of the completed application from each contestant, along with the required proof of age, picture and entry and program ad fees, the applicant will then receive pertinent information regarding the pageant.

By my signature on this application, I hereby certify that I have read and completely understand the accompanying Official Rules and Regulations of the Miss Rodeo Oregon Sweetheart Pageant and I have also read and understand the accompanying Miss Rodeo Oregon Sweetheart Contract that I acknowledge the rules and regulations, as well as, the Miss Rodeo Oregon Sweetheart Contract to apply to myself at all times during my competition in the Miss Rodeo Oregon Sweetheart Pageant, it's programs, activities and functions; that said rules and regulations pertain to all persons related to my appearance in the Pageant; and that the Miss Rodeo Oregon Pageant, Inc., will rely upon my execution hereof and all terms and conditions set forth herein, in permitting my appearance and participation in the Miss Rodeo Oregon Sweetheart Pageant.

By the execution hereof, I hereby RELEASE and HOLD the Miss Rodeo Oregon Pageant, Inc., and the Miss Rodeo Oregon Sweetheart Pageant, the officers, directors, accredited sponsors both commercial and private, employees, agents, members and/or representatives of each, HARMLESS from any and all rights, claims and actions, direct or indirect, fixed or contingent, of whatsoever kind or character, as shall now exist and hereafter arise from, and be the result of, my actions, or persons related to, my appearance or participation in the Miss Rodeo Oregon Sweetheart Pageant, its programs, activities or functions. The undersigned does acknowledge that they are familiar with equestrian and rodeo sports and activities and that the same are inherently dangerous to herself and those related to her participation therein. The undersigned further acknowledges that the Miss Rodeo Oregon Pageant, Inc. and the Miss Rodeo Oregon Sweetheart Pageant cannot and does not guarantee the safety or well being of any participant does not guarantee against harm to the participant, does not guarantee the conduct of any participant other than the undersigned. The undersigned acknowledges that this release and indemnification is executed without specific knowledge of existing or future rights, claims, or actions, but executes the same notwithstanding such lack of knowledge, the risk thereof being known by, and assumed by, the undersigned and found to be reasonable for her assumption.

By the execution hereof, the undersigned does:

1. Grant permission to the Miss Rodeo Oregon Pageant, Inc., and the Miss Rodeo Oregon Sweetheart Pageant to verify any and all information contained herein by and through information held by persons other than the undersigned and shall execute and deliver to the above-named entities such documents as are required to obtain any and all information reasonably necessary to verify any and all such information,
2. Certify the participant to be the appropriate age as evidenced by the Certificate of Birth attached.
3. Miss Rodeo Oregon Sweetheart can participate in events ONLY in her local community. She cannot travel throughout the state as the Miss Rodeo Oregon Sweetheart representative and

cannot participate in any horse activities, including rodeos and parades. Any and all activities she participates in must be approved by the Miss Rodeo Oregon Pageant, Inc. Board of Directors.

- 4. Miss Rodeo Oregon Sweetheart is NOT allowed to engage in any fund-raising activities, and cannot advertise herself or the program without express written consent of the Miss Rodeo Oregon Association.

The undersigned does agree that (a) the foregoing certifications and agreements are continuing in nature, (b) upon failure of any certification or authorization set forth above, and (c) if the undersigned shall fail to provide notice of the change in any of the above certifications and authorizations during her participation in the Miss Rodeo Oregon Sweetheart Pageant, she will automatically and without notice be disqualified from further participation in the Miss Rodeo Oregon Sweetheart Pageant, and does hereby agree to indemnify and hold the Miss Rodeo Oregon Sweetheart Pageant, the Miss Rodeo Oregon Pageant, Inc., together with the officers, directors, accredited sponsors both commercial and private, employees, agents, members or representatives of each, harmless as against all rights, claims and actions arising by reason thereof.

Applicant agrees and stipulates that disqualification from participation in the Miss Rodeo Oregon Sweetheart Pageant either before or after the competition will result in damages to the Miss Rodeo Oregon Association. In this regard, applicant agrees to pay the Miss Rodeo Oregon Pageant, Inc. a sum equal to all monies and consideration received as the result of applicant's participation in the Miss Rodeo Oregon Sweetheart Pageant, the same being declared liquidated damages as between the parties.

In the event the undersigned shall receive the title of Miss Rodeo Oregon Sweetheart, she agrees to complete the tenure of title in accordance with the rules and regulations of the Miss Rodeo Oregon Association; shall at all times act in the best interest of and to promote the Miss Rodeo Oregon Sweetheart Pageant; make such public appearances as shall be designated by the Miss Rodeo Oregon Association, without compensation for time and/or service; and shall relinquish and deliver to the Miss Rodeo Oregon Sweetheart Pageant, all claims and accouterments (crown, banner, etc.) as shall relate to the title of Miss Rodeo Oregon Sweetheart, all upon the naming of a successor to such title.

This agreement shall be binding upon all heirs, assigns, successors, trustees, receivers, legally appointed guardians, administrators, executors and personal representatives of the Miss Rodeo Oregon Junior/Teen Pageant, the Miss Rodeo Oregon Pageant, Inc., and the undersigned. This is a legal instrument for which an attorney and accountant should be consulted. The undersigned do affix their signatures hereto without reserve.
