 - Please include the fully completed application in an electronic format as well as printed originals via CD, thumb drive or emailed.

- ❑ **Horsemanship prerequisites:**
 - Provide (1) Horsemanship Letter of Recommendation

 - Provide Horsemanship Video including elements of control at a walk, jog, lope, back, change of direction, a flag carry and presentation run. Video to be no more than three minutes in length.

- ❑ **1- 8X10 Color Photo - for the Photogenic Contest** (Photo's will be returned) Please include both the photo along with an electronic version on CD or email.

- ❑ **2- Black & White, 5X7 Photos**

The purpose of Miss Rodeo Oregon Inc. Foundation is to provide a program for Oregon horsewomen that encourages positive growth in strength of character and personality, healthy attitudes, self-fulfillment and self-respect. The Junior and Teen Miss Rodeo Oregon Pageants are organized to select the most qualified Oregon horsewomen to promote the sport of professional rodeo in Oregon and to represent the State of Oregon.

Pageant Eligibility Requirements

*******Any Contestant not meeting the qualifications below shall be denied the right to compete in the Junior/Teen Miss Rodeo Oregon Pageant, please read carefully*******

1. Junior Miss Rodeo Oregon Contestants must reach the age of 8 by June 30th, of the pageant year that they are competing and not exceed the age of 13 as of December 31st of the same pageant year.
2. Miss Teen Rodeo Oregon Contestants must reach the age of 13 by June 30th, of the pageant year that they are competing and not to have exceeded the age of 18 as of December 31st of the same pageant year.
3. Proof of age is to be provided, i.e. a notarized copy of the Contestant's Oregon Drivers License or True copy of Contestants Birth Certificate.
4. Must be a resident of Oregon for the immediate six months prior to pageant. Notarized copy of Parent / Guardian Oregon Drivers License as proof of Residency or Contestant Drivers License.
5. Must not have previously been, or presently be, married and/or pregnant.
6. Must execute all consents and/or waivers of liability presented as conditions prior to competition.
7. If Contestant is not presently enrolled in school, she must be a high school graduate or hold a GED.
8. Shall abide by all rules and regulations of Miss Rodeo Oregon Inc. Foundation.
9. Must not have ever been convicted of a crime.
10. The rules and regulations of the Miss Rodeo America Pageant are hereby incorporated by reference as part of the Junior/Teen Miss Rodeo Oregon Pageant Rules and Regulations.

11. The winning Junior and Teen contestants shall be required to follow guidelines and contract provided to her and signed by her and her parent and or legal guardian.
12. Pageant Application must be accepted.

By the execution hereof, I hereby RELEASE and HOLD the Miss Rodeo Oregon Inc. Foundation, and the Miss Rodeo Oregon Junior/Teen Pageant, the officers, directors, accredited sponsors both commercial and private, employees, agents, members and/or representatives of each, HARMLESS from any and all rights, claims and actions, direct or indirect, fixed or contingent, of whatsoever kind or character, as shall now exist and hereafter arise from, and be the result of, my actions, or persons related to, my appearance or participation in the Miss Rodeo Oregon Junior/Teen Pageant, its programs, activities or functions. The undersigned does acknowledge that they are familiar with equestrian and rodeo sports and activities and that the same are inherently dangerous to herself and those related to her participation therein. The undersigned further acknowledges that the Miss Rodeo Oregon Inc. Foundation and the Miss Rodeo Oregon Junior/Teen Pageant cannot and does not guarantee the safety or well being of any participant does not guarantee against harm to the participant, does not guarantee the conduct of any participant other than the undersigned. The undersigned acknowledges that this release and indemnification is executed without specific knowledge of existing or future rights, claims, or actions, but executes the same notwithstanding such lack of knowledge, the risk thereof being known by, and assumed by, the undersigned and found to be reasonable for her assumption.

By the execution hereof, the undersigned does:

1. Grant permission to the Miss Rodeo Oregon Inc. Foundation, and the Miss Rodeo Oregon Junior/Teen Pageant to verify any and all information contained herein by and through information held by persons other than the undersigned and shall execute and deliver to the above named entities such documents as are required to obtain any and all information reasonably necessary to verify any and all such information,
2. Certify the participant to be the appropriate age as evidenced by the Certificate of Birth attached.

The undersigned does agree that (a) the foregoing certifications and agreements are continuing in nature, (b) upon failure of any certification or authorization set forth above, and (c) if the undersigned shall fail to provide notice of the change in any of the above certifications and authorizations during her participation in the Miss Rodeo Oregon Junior/Teen Pageant, she will automatically and without notice be disqualified from further participation in the Miss Rodeo Oregon Junior/Teen Pageant, and

does hereby agree to indemnify and hold the Miss Rodeo Oregon Junior/Teen Pageant, the Miss Rodeo Oregon Inc. Foundation, together with the officers, directors, accredited sponsors both commercial and private, employees, agents, members or representatives of each, harmless as against all rights, claims and actions arising by reason thereof.

Applicant agrees and stipulates that disqualification from participation in the Miss Rodeo Oregon Junior/Teen Pageant either before or after the competition will result in damages to the Miss Rodeo Oregon Association. In this regard, applicant agrees to pay the Miss Rodeo Oregon Inc. Foundation a sum equal to all monies and consideration received as the result of applicant's participation in the Miss Rodeo Oregon Junior/Teen Pageant, the same being declared liquidated damages as between the parties.

In the event the undersigned shall receive the title of Miss Rodeo Oregon Junior/Teen, she agrees to complete the tenure of title in accordance with the rules and regulations of the Miss Rodeo Oregon Association; shall at all times act in the best interest of and to promote the Miss Rodeo Oregon Junior/Teen Pageant; make such public appearances as shall be designated by the Miss Rodeo Oregon Association, without compensation for time and/or service; and shall relinquish and deliver to the Miss Rodeo Oregon Junior/Teen Pageant, all claims and accouterments (crown, banner, etc.) as shall relate to the title of Miss Rodeo Oregon Junior/Teen, all upon the naming of a successor to such title.
